Privacy Policy

Protecting your private information is our priority. This Statement of Privacy (the "Privacy Policy") applies to the URL <http://www.noafrankjewelry.com/> (the "Site") and Noa Frank Jewelry LLC ("Noa Frank," "our," "us," or "we") and governs data collection and usage. For the purposes of this Privacy Policy, unless otherwise noted, all references to Noa Frank include <http://www.noafrankjewelry.com/> and Noa Frank Jewelry LLC. By using the Site, you ("you" or "your") consent to the data practices described in this Privacy Policy.

Collection of your Personal Information

We may collect personally identifiable information, such as your name. If you purchase Noa Frank Jewelry products and services, we collect billing and credit card information. This information is used to complete the purchase transaction. We may also collect anonymous demographic information, which is not unique to you, such as your age, gender, geographic location and other anonymous demographic information. We may gather additional personal or non-personal information in the future.

Information about your computer hardware and software may be automatically collected by Noa Frank Jewelry. This information can include: your IP address, browser type, domain names, access times and referring website addresses. This information is used for the operation of the service, to maintain quality of the service, and to provide general statistics regarding use of the Site.

We encourage you to review the privacy statements of websites you choose to link to from Noa Frank Jewelry so that you can understand how those websites collect, use and share your information. We are not responsible for the privacy statements or other content on websites outside of the Site.

Use of your Personal Information

We collect and use your personal information to operate our Site and deliver the services and or goods you have requested.

We may also use your personally identifiable information to inform you of other products or services available from Noa Frank Jewelry and its affiliates. We may also contact you via surveys to conduct research about your opinion of current services or of potential new services that may be offered.

We do not sell, rent or lease its customer lists to third parties.

We may, from time to time, contact you on behalf of external business partners about a particular offering that may be of interest to you. In those cases, your unique personally identifiable information (e-mail, name, address, telephone number) is not transferred to the third party. We may share data with trusted partners to help perform statistical analysis, send you email or postal mail, provide customer support, or arrange for deliveries. All such third

parties are prohibited from using your personal information except to provide these services to Noa Frank Jewelry, and they are required to maintain the confidentiality of your information.

We may keep track of the websites and pages our users visit within the Site, in order to determine which Noa Frank Jewelry services are the most popular. This data is used to deliver customized content and advertising within Noa Frank Jewelry to customers whose behavior indicates that they are interested in a particular subject area.

We will disclose your personal information, without notice, only if required to do so by law or in the good faith belief that such action is necessary to: (a) conform to the edicts of the law or comply with legal process served on Noa Frank Jewelry or the Site; (b) protect and defend the rights or property of Noa Frank Jewelry; and, (c) act under exigent circumstances to protect the personal safety of users of Noa Frank Jewelry, or the public.

Use of Cookies

Our Site may use “cookies” to help you personalize your online experience. A cookie is a text file that is placed on your hard disk by a web page server. Cookies cannot be used to run programs or deliver viruses to your computer. Cookies are uniquely assigned to you, and can only be read by a web server in the domain that issued the cookie to you.

One of the primary purposes of cookies is to provide a convenience feature to save you time. The purpose of a cookie is to tell the Web server that you have returned to a specific page. For example, if you personalize Site pages, or register with Noa Frank Jewelry, the Site or its services, a cookie helps us to recall your specific information on subsequent visits. This simplifies the process of recording your personal information, such as billing addresses, shipping addresses, and so on. When you return to the Site, the information you previously provided can be retrieved, so you can easily use the Site features that you customized.

You have the ability to accept or decline cookies. Most Web browsers automatically accept cookies, but you can usually modify your browser setting to decline cookies if you prefer. If you choose to decline cookies, you may not be able to fully experience the interactive features of Noa Frank Jewelry, its services or other websites you visit.

Security of your Personal Information

We secure your personal information from unauthorized access, use or disclosure.

Children Under Thirteen

We do not knowingly collect personally identifiable information from children under the age of thirteen. If you are under the age of thirteen, you must ask your parent or guardian for permission to use this website.
